## Subject: Acceptance of Affidavits sworn before/attested by Executive Magistrate.

It has been decided that the Affidavits (i.e., Annexure 'A', 'C', 'D', 'E', 'I' and 'L') submitted with the Passport Application form sworn before/ attested by Executive Magistrate may also be accepted henceforth as valid documents. The consolidated list of Affidavits / Annexures with the concerned authorities before whom it should be sworn / attested by is reproduced below:
